NOTE: THE COLLIER COUNTY FAIR DOES NOT SELL LIABILITY INSURANCE.

Individual Vendors are responsible for carrying liability insurance for the 2018 Country Jam. Each policy must be for at least \$1,000,000 (one million dollars).

Each policy MUST list the following as:

“Additional Insured”:

- The Collier County Agricultural Fair and Exposition, Inc.
- The Collier County Government
- The Collier County Board of Commissioners
- The Collier County Fair Board

All of these must be on your policy or it will not be accepted!

All Golf Carts that are being used by vendors on the fairgrounds must show proof of coverage on them or you will not be allowed to drive them on the fairgrounds.

Please also submit a copy of your “Workmen’s Compensation policy.

Once your application has been accepted, you are required to provide the Fairgrounds with your proof of Insurance. **All policies must be submitted to our Insurance Company for approval, therefore we must receive all vendor/concession policies by January 14, 2018. Vendors who arrive without proof of Insurance will not be allowed to set up.**

This form must be signed, dated and returned to us stating that you have received these requirements and understand them.
